

## Associate Professor – Clinical, Social, Administrative Pharmacy

The [Leslie Dan Faculty of Pharmacy](#) at the University of Toronto invites applications for a full-time tenure stream appointment in Clinical, Social and Administrative Pharmacy (CSAP) division of the Pharmaceutical Sciences department at the rank of Assistant Professor, with an anticipated start date of September 1, 2022.

We seek applications from candidates whose research complements the [research programs](#) of the highly collaborative faculty currently in the CSAP division. Relevant areas of research include but are not limited to: public health, health services, pharmacoepidemiology, pharmacometrics, interprofessional education, health economics/pharmacoeconomics, integrated care, pharmacy practice research, digital health, data sciences/ artificial intelligence, implementation science, health equity, and the sociobehavioural aspects of medication management.

### Qualifications

The successful candidate must have completed a PharmD program plus a graduate degree in a related area (pharm sciences in public health, health research methods, data sciences) or completion of a clinical fellowship of at least 2 years. Alternatively, they must have a PhD in Pharmacy, Pharmaceutical Sciences or related Health Sciences fields, Public Health, Health Research Methods, Data Sciences, Health Services, Health Policy, Health Management or a related area. Postdoctoral experience, or equivalent (e.g. government, health care organization or industry), in an area related to one of the five overarching research areas in [pharmaceutical sciences research](#) that will build on the strengths of the CSAP Faculty is preferred. Candidates must have a clearly demonstrated exceptional record of excellence in research and teaching. Candidates must have experience leading or participating in collaborative research and demonstrated ability to work across disciplines in multidisciplinary research and/or teaching initiatives. The successful candidate will be expected to sustain and lead an independent, innovative, externally funded and internationally recognized research program. This candidate will be expected to contribute to the education and training of undergraduate students in our [PharmD](#) professional programs and graduate students in [Pharmaceutical Sciences](#).

Candidates must provide evidence of research excellence which can be demonstrated by a record of sustained high-impact contributions and publications in top-ranked and field relevant journals, the submitted research statement, presentations at significant conferences, distinguished awards and accolades, and other noteworthy activities that contribute to the visibility and prominence of the discipline, as well as strong endorsements from referees of high standing.

Evidence of excellence in teaching will be provided through teaching accomplishments, the teaching portfolio including a teaching statement, sample course materials, and teaching evaluations submitted as part of the application, as well as strong letters of reference.

Equity and diversity are essential to academic excellence. We seek candidates who value diversity and whose research, teaching and service reflect our [commitment to equity and inclusion](#). Candidates are therefore asked to include a statement discussing past, current and/or planned contributions to equity and diversity, which might cover topics such as (but not limited to): research or teaching that incorporates a focus on underrepresented communities, the development of inclusive pedagogies, public engagement activities that reach out to marginalized communities, and mentoring of students from underrepresented groups.

- a current curriculum vitae
- a statement of research interests (3 page limit)
- a teaching portfolio to include a teaching statement (3 page limit) plus supporting documents to include sample course materials, and teaching evaluations
- an equity and diversity statement (outlined above; 1 page limit)
- three representative publications or working papers
- Applicants must provide the name and contact information of three references. The University of Toronto's recruiting tool will automatically solicit and collect letters of reference from each after an application is submitted (this happens overnight). Applicants remain responsible for ensuring that references submit letters (on letterhead, dated and signed) by the closing date.
